Privacy Statement Van der Wal

We, logistics service provider Van der Wal (hereafter: Van der Wal), residing at Nijverheidsweg 33, 3534 AM in Utrecht, The Netherlands, are responsible for processing personal data like described in this privacy statement.

We respect the privacy of all our stakeholders, including website visitors, customers, suppliers and employees. We make sure that the personal data which we receive is handled with the utmost care.

We know that you confide in us. Therefore we view it as our responsibility to protect your privacy. With this privacy statement we inform you about the data we collect and why we collect this data. This way you will exactly know how we operate.

What personal data do we process?

We process, amongst others, the following personal data:

- First and last name
- Address
- Telephone number
- Email address
- IP address
- Location

With which purpose and on what legal ground do we process personal data?

Van der Wal processes your personal data for multiple purposes. For example, when you request a proposal or when the processing is necessary to meet the obligations out of a contract we have with you. We also process personal data for marketing purposes and to inform you about a change in our products and services.

Van der Wal processes your personal data only when one of the following legal grounds apply:

You gave clear consent to process your personal data for a specific purpose;

- Processing is necessary to meet the obligations out of a contract we have with you;
- · Processing is necessary for us to comply with the law;
- Processing is necessary to protect someone's life;
- Processing is necessary for us to perform a task in the public interest. The task has a clear legal basis;
- Processing is necessary for our legitimate interests or the legitimate interests of a third
 party, unless there is a good reason to protect the individual's personal data which
 overrides those legitimate interests.

Providing personal data to a third party?

Your personal data will not be provided to a third party without your clear consent, unless this is necessary for handling a contract, delivering a specific service or if the law obliges us.

Do we provide personal data to locations outside of the EU?

Van der Wal and affiliates also transport outside of the EU. To make sure that your personal data is protected, we make agreements with these parties like prescribed by the European Commission. That way your personal data is equally protected, inside and outside of the EU.

For how long do we keep your personal data?

Van der Wal does not keep personal data for longer than strictly necessary to realize the purpose for which data has been collected.

How do we protect your personal data?

Van der Wal is serious about protecting your personal data and takes appropriate measures to ensure abuse, loss, prohibited access, unwanted publication and changes. Which rights do you have?

You have the right to request to access, correct and erase personal data. You also have the right to withdraw consent or to object against the processing of your personal data by Van der Wal. And lastly you have the right to data portability. This means that you can send us a request to transfer your personal data to you personally or a third party.

You can send your request to access, correct, erase and transfer data or your request to withdraw your consent or object against processing your personal data to info@vanderwal.company. We will respond as soon as possible, but within six weeks, to your request.
